- 5. **Fred Hicks**: Damage done when water flooded swathed field affecting approximately 5 acres of hay in windrow.
- 6. **John Douglas**: Ditch was overfilled and water entered the crawl space beneath the home. No damage to foundation at this time other than wetness in the crawl space.
- 7. **Jesse Renfro**: Flood damage to yard, garage, basement and home. Heating and air conditioning duct replaced by the District.
